Data Protection Policy

This policy contains the guidelines of Becton Dickinson Rowa Germany GmbH ("BD"), Rowastraße, 53539 Kelberg, Germany, regarding the use of cookies and, in addition to the terms and conditions of use, BD's fundamental principles regarding the treatment of the personal data that are collected, processed, and used when visiting the Rowa online portals. BD respects the privacy of its online visitors.

BD takes data protection very seriously. BD makes every effort to collect and use personal data in compliance with the respectively applicable data protection legislation. By using or registering on the Rowa online portals, the user accepts the following data protection conditions. If the user does not accept the data protection conditions, they should not use or register on the portals.

BD collects personal data at various points when the Rowa online portals and their subsections are used. With this data protection policy, we want to explain to the user what data are required and how the user can access extra features by providing additional data voluntarily.

Withdrawing your consent to data processing

Some data processing procedures are only possible with your express consent. You have the right to withdraw your granted consent at any time. To do so, simply send an e-mail with your consent withdrawal request to GDPR@bd. com. The lawfulness of processing based on consent before its withdrawal is not affected by the withdrawal.

Right to lodge a complaint with a supervisory authority

As an affected data subject, you have the right to lodge a complaint with the supervisory authority in case of a data protection breach. Cookies and log files

For the operation of the online customer portal we only use the necessary technical cookies which are required for the operation of the said portal and its functions. These include session cookies, which save your defined settings (e.g., language preference) and flash cookies for playing media content.

While the user is visiting the Rowa online portals, the web server collects general technical information for operation of the offering, in particular concerning the software and hardware used by the user, the computer's IP address, which sections the user has visited, and the time and duration of their visit. These data are not linked to the user personally. The data collected are not connected with any registration data. BD saves these data as server log files on the Rowa online portals' server. The server log files are saved for maximum 30 days and then deleted. The data are saved for security reasons, for example to clarify cases of misuse. If data need to be kept for evidentiary reasons, they are exempt from the deletion rule until such time as the case has been definitively resolved.

Collected personal data

We collect data on or via the Rowa online portals that can be directly linked to your person and can be used to identify you, but only such data that you provide voluntarily. These personal data include, for example, your name, your address, your telephone number, and your e-mail address.

Data collection and purpose of data collection

The Rowa online portals are operated by BD. BD is the responsible authority with regard to the personal data collected via the Rowa online portals. BD undertakes only to collect personal data in accordance with the legal requirements. We collect, process, and use the personal data made available in this way to fulfill our contractual and/or precontractual obligations and for specific purposes such as responding to your technical or general questions or being able to grant you access to the information you requested. Insofar as we have procured your consent to the processing of personal data, Article 6 1. (A) of the European General Data Protection Regulation (GDPR) applies as the legal basis.

Handling of the data you enter in the contact form

If you contact us using the contact form provided, your data will be saved so as to be available if required when processing and answering your inquiry. These data are not provided to third parties without your consent.

Disclosure of your personal data

Under certain circumstances, your personal data may be shared with other members of the BD Group. Some companies in this Group have their headquarters in countries where different data protection legislation applies compared with the European Economic Area and an adequate degree of data protection as defined by the European data protection directive (95/46/EC) is therefore not guaranteed. In all such cases, we employ the necessary technical and organizational measures to ensure the protection of your personal data. We only provide your data to others in accordance with requirements whereby the recipients are obligated to ensure data protection and the security of your personal data. In particular, we conclude the commissioned data processing agreements required by the pertinent legislation, which oblige the service providers to implement adequate technical and organizational measures to protect your personal data and to process them exclusively in accordance with our instructions and not for any other additional purposes.

In the context of the sale of one or more brands or a part of our company to another company, we reserve the right to pass your personal data on to the new owner. In this case, too, we will make the efforts outlined above to ensure the protection and security of your personal data.



With the exception of the cases defined in this data protection policy and prescribed by law, we only provide your personal data to third parties if you have granted your consent or you were informed at the time you provided them of the possibility of the personal data being passed on in such cases.

Non-personal data

All non-personal data, correspondence, and materials that you transmit to the Rowa online portals or send to us via e-mail are not considered confidential. We are entitled to use and reproduce these data without restrictions and for any purpose. In particular, we are entitled to use any ideas, concepts, knowledge, or processes contained in these data for any purpose, for example for the development, production, and marketing of products. All data that you transmit to this website must be true, legal, and not infringe the rights of third parties.

Security

We employ physical, technical, and organizational procedures to protect your personal data from being accessed accidentally, without authorization, or illegally, from being copied without authorization, from being used without authorization, from being processed, disclosed, modified, or

transmitted, and from being lost or destroyed. Our security policies ensure the integrity of the data that we store concerning your person and we restrict access to these data strictly. Our web servers and our Rowa online portals are equipped with focused security measures and we monitor our server security constantly in order to prevent security breaches effectively.

Access to your data and rectifications

You are entitled to request a copy of the data that we store concerning your person. You also have the possibility of demanding the erasure or rectification of the data stored concerning you and/or to object to data processing for legitimate reasons. Please send an e-mail to the address provided in the Imprint. We may apply a small charge for this service. We want your personal data to be free from errors and up to date at all times. For this reason, you may ask us to rectify erroneous information or erase it completely at any time.

Erasure of personal data

Your personal data are only stored for as long as they are required for the purpose for which they were collected or as long as their storage is required for legal reasons.

Changes to this data protection policy

We are entitled to change this policy at any time at our discretion. All changes enter into force immediately as soon as the corresponding changes are published on this website. Unless otherwise specified, this agreement applies exclusively for this website and our online activities but not for our offline activities.

Other websites

Our Rowa online portals contain links to other websites. This data protection policy applies exclusively to the Rowa online portals. As such, if you visit another website using a link, please read the corresponding data protection policy of the other website.

Marketing

You only receive marketing material from us if you have agreed to receive said information. Each marketing e-mail offers the recipient the option of unsubscribing from future marketing material. You are entitled to request that we do not contact you for marketing purposes any more at any time.
